## 2015 DEPUTY SHERIFFS' BASIC TRAINING REVISED

The schedule of 2015 basic and waiver training classes is provided below to assist sheriffs in projecting their training plans. To be in compliance with Act 1984-2, any deputy hired by the sheriff has one year in which to complete his or her training and be certified by the Deputy Sheriffs' Education and Training Board (DSETB).

Applications for partial waiver of basic training shall be submitted on PCCD Form-105, Basic Training Partial Waiver Application. This form is available at the PCCD Website, [www.pccd.pa.gov](http://www.pccd.pa.gov), along with other PCCD forms. Applicants must submit proof of training or experience as a municipal police officer in Pennsylvania or experience as a Pennsylvania State Trooper. Proof of current first aid, CPR (Adult, Child and Infant), and firearms qualifications must also be included. Deputies cannot register for waiver training until their application for waiver is approved.

Sheriffs are required to utilize the on-line enrollment process available through the use of the Deputy Sheriffs' Information System (DSIS). Accessing the DSIS will assist your office in better management of your training needs and requirements. You will have instant access to your deputies training records and the ability to monitor their training status.
