#### **Executive Director Burns:**

- Executive Director Burns reported that a Course 2 Critical Incident Report Writing (revised) Train the Trainer class was conducted on February 26, 2009 and instructed by Mr. Thomas Benge. Mr. Thomas Benge also instructed a class on February 27, 2009 which was professionally video-taped by Commonwealth Media Services.
- Executive Director Burns announced that Right to Know Law CD's were mailed to the Commissioners. Applications were then given to all Commissioners and sub-committee chairs to set-up state e-mail accounts in compliance with the Right to Know Law. Those not in attendance will have their applications mailed to them.

#### 5. REPORTS of OFFICERS and STANDING COMMITTEES

### **Executive Director Burns:**

- □ Executive Director Burns reported a fund balance of \$1,002,263 and provided a current Expenditure Report to the Commissioners.
- Executive Director Burns presented a summary of the Program Revision Request (PRR) report. The report proposed hiring additional state employee instructors for the commission. Additionally Mr. Burns is working with the Human Resource office to find out if the commission is able to directly hire independent contractors.

### **CURRICULUM SUB-COMMITTEE:**

- Mr. Erik Christensen presented several issues to the Commission members. He reported that the Curriculum Committee is exploring expanding Course 1 Basic Training to include: Adding more days of training; weapons retention instruction; integrating Course 3 into the Basic curriculum; eliminating the 25 yard line from qualification; changing the scoring system; and ballistic protection discussion. The Curriculum Committee will be discussing these issues thoroughly in future meetings.
- Mr. Robert Repard reported he received correspondence from Chief John Holt, Crawford County Adult Probation, to explore the use of AirSoft as a future Commission Continuing Education Training course. After discussion, the commission decided to answer Chief Holt's query with a letter explaining the commission's position on AirSoft as a viable alternative for future training.

- □ Mr. Erik Christensen reported that all continuing education manuals have been updated for the 2009 training year.
- Mr. Erik Christensen provided an update to the Board of Probation and Parole's offer to host a Certified Firearms Instructor course for county probation officers.
   Mr. Gary Holland provided additional details about the training. Executive Director Burns will provide the curriculum committee copies of the course.
- □ Chairman Schlechter discussed developing additional continuing education courses for the commission. Chairman Schlechter commented on the possibility of attending training to research the feasibility of additional courses.
