## 2. Review and approval of the Minutes of the previous meeting

Commissioner Shurtleff made a motion to approve the minutes from the March 14, 2019 Firearms Education and Training Commission meetings.

## 3. Announcements and Reports

## **Executive Director MacLaughlin**

• Executive Director MacLaughlin stated that FETC successfully ran it's first Basic Training Academy of the year and all of the students passed.

- Executive Director MacLaughlin mentioned that he worked with PWT on a Train-The-Trainer to help catch some of the probation officers up on training so they can help assist with the Con Ed trainings.
- Executive Director MacLaughlin shared that he went to Schuylkill County and helped assist with a couple Course 6, Lasershot, classes. While he was there he performed a site evaluation and everything looked good.
- Executive Director MacLaughlin announced that the Curriculum Committee ran a Course 3 in Bucks County and identified the problems they previously had to get the timing down. It ran much smoother with the corrected timing.
- Executive Director MacLaughlin reported there were complaints from a county about a range that was used for a Con Ed class that PWT ran. There was some splashback due to the metal backers used. PWT made the adjustments on the spot to maintain safety, but was asked to not use that range for any future trainings.
- Commissioner Christensen stated unless the injury forms are filled out at the end of the training day, which they weren't due to the students not feeling injured at the time, the vendor did all they needed to do.
- Commissioner Heitzman mentioned about possibly asking the vendors to push a little harder at the end of training day if they think somebody might be slightly injured.
- Executive Director MacLaughlin mentioned he successfully qualified with Dauphin County.
- Executive Director MacLaughlin shared a situation with Westmoreland County, where they brought up concerns they weren't getting enough of a variety of trainings available. Executive Director MacLaughlin explained to them that each geographical region gets the same amount and same variety of classes. Some classes just fill up quicker than others and counties have to sign up as early as possible to attend specific courses.
- Executive Director MacLaughlin asked the Commission about the possibility of having FETC run the CFI Course from now on. Since the MOU with the DOC occurred the PBPP training staff is having a very difficult time finding the time to run the course.
- Executive Director MacLaughlin proposed having instructors from across the state help assist with the CFI Course, with the same curriculum, so the courses can continue to run.
- Commissioner Libby asked about the selection of instructors who would help assist and what kind of qualifications would be needed to help assist with the CFI Course. He suggested possibly limiting it to MI's only.
- The Commission asked for a written proposal including a guideline and minimum criteria for instructors helping teach, and potential fiscal impacts due to the instructors and amount of courses in a year for the July meeting.

- Executive Director MacLaughlin shared the positive reaction from the students who attended the new Course 3.
- Commissioner Heitzman stated his county, Northumberland, ran two Course 3's and it was very successful and he received a lot of positive feedback from his students as well.
- Executive Director MacLaughlin stated they are now looking at one final Train-The-Trainer and Course 3 for the western part of the state in July.
- Executive Director MacLaughlin shared that, due to becoming the Chief, Neil Stefanisko will have to leave the Curriculum Committee.
