# 1. Call to Order and the Pledge of Allegiance

# 2. Review and approval of the Minutes of the previous meeting

• Legal Advisor John Manning noted a required correction on the previous meeting minutes, on page two, under "Status of the new Fiscal Contract" which reads "purposal" where it should read "proposal".

#### MOTION: 1605:01

Commissioner Dombrowsky made a motion to approve the March 17, 2016 Commission Meeting Minutes with the suggested correction. Commissioner Libby seconded.

Motion passed by unanimous voice vote.

#### 3. Announcements

#### **Chairman Keith Graybill**

- Introduced Ian Rowles, FETC Clerk Typist III, who is assisting with todays minutes.
- Welcomed back Janet Collins, PBPP Training Division, who is assisting with note taking for the meeting.
- Commissioner Beth Dombrowsky has been appointed by Governor Wolf as a
  commission member of Municipal Police Officers' Education and Training Commission,
  and she was confirmed by the Senate and the House. This will be the last meeting for
  Commissioner Dombrowsky.

 Chairman Graybill reported Commissioner Scott Schlecter also completed his term as a Commissioner after many years of service and thinks it would be nice to recognize Commissioner Schlecter and Commissioner Dombrowsky with a plaque.

# MOTION: 1605:02

Commissioner Libby made a motion to recognize Commissioner Beth Dombrowsky and Commissioner Scott Schlechter for their years of service with leadership and commitment to the Firearms Commission.

Commissioner Beaver seconded.

Commissioner Dombrowsky abstained.

Motion passed by voice vote.

- Chairman Graybill appointed Dave Christian, who is the Dauphin County training coordinator, to the Curriculum Committee on the recommendation of Eric Burkholder.
- Chairman Graybill announced there will be a need to appoint a review committee for the Executive Director position once the request for proposal has been let. There will be a screening of the applicants that come in. Commissioner Libby and Commissioner Beaver offered to join the committee alongside Chairman Graybill.

## **Advisor Greg Young**

- Advisor Greg Young provided information regarding the two basic trainings, one range in April where eleven attended the academy and only one failed. The second training was taking place for two weeks in May, 3-6 and 10-13. All twenty are looking like they will pass.
- Advisor Greg Young mentioned the Executive Director position has been posted and comes down on May 19, 2016. A copy of the posting will be sent to every county Approved Authority.

#### **Fiscal Report**

- Advisor Greg Young showed the breakdown of the new revenue received, by month, by the finance department. The new revenue being from new assessments.
- The AOPC sent their quarterly workbook packet to be included, broken down by county to see individual revenue taken in.
- Chairman Graybill mentioned looking at the Fiscal Report for the past couple of years
  and blending together patterns in how much was collected, how much was assessed and
  how much remains unclaimed to see where each of the catergories stand as of this fiscal
  year.

#### 4. Reports of Officers and Standing Committees

#### **Chairman Graybill**

• Chairman Graybill announced that he met with Chairman Leo Dunn to talk about the approval of the Executive Director position. Also discussed about the status of the two expired Commission positions.

- Chairman Leo Dunn has pursued the issue with the Governor's Office, and suggests that Chairman Graybill write a letter to the same office. In the letter Chairman Graybill included a list of recommended appointees from the Chiefs Association.
- Chairman Graybill expressed his appreciation to Chairman Leo Dunn for his support of the commission and the support the board is offering through the training division.
- Chairman Graybill discussed the vacant Executive Director interview process and how
  the more recent interview process played out. Stated several members of the Commission
  selected and interviewed applicants and then recommended several people for the full
  commissioner interview. Chairman Graybill appointed Commissioner Beaver,
  Commissioner Libby and Advisor Young to serve with him for the interview for the
  initial interviewing screening.

#### **Curriculum Committee**

The Curriculum Committee did not meet since the previous Commission Meeting.

- Advisor Greg Young did announce that the Curriculum Committee reworked all of the drills that are done at the basic trainings.
- Curriculum Committee should be working on adjustments to drills for the next range which takes place in September.

The Committee on Budget Alignment, Officer Safety Research Committee, and Policy Committee, did not meet since the previous Commission Meeting.

#### 7. New Business

## **New In-Service Training Contract Update**

- Advisor Greg Young mentioned that he met with fiscal, and mentioned the cumbersome nature of payments for classes. Had to pay for each class, and fill out paperwork for each individual instructor. Everything is broken down to an individual piece.
- Advisor Greg Young stated how they're in the process of creating new forms to help with payments for training classes so it becomes easier going forward.
- Chairman Graybill brought up the burden on counties to meet the requirements for training for every probation officer. Wanted to bring up the possibility of offering relief to counties from some of their obligations, within regulation guidelines.
- Commissioner Chad Libby brought up the issue multiple counties could have with inservice trainings due to lack of resources. How it looks in the books with people getting credit compared to others.
- Advisor Greg Young brought up how Allegheny county has a training involving multiple surrounding counties. A problem lies when some counties and their surrounding counties don't have the resources or even a Master Instructor.
- Advisor Greg Young and Commissioner Chad Libby discussed a situation where, if the
  instructors wouldn't be able to be financially paid for their help they would have to seek
  volunteers to help.

#### MOTION: 1605:03

Commissioner Libby made a motion for the 2016 FETC continued education program curriculum be offered by the commission with certified instructors. Of those courses, they will be reimbursed based on the Commonwealth's travel policy.

Commissioner Beaver seconded.

Advisor Greg Young, Legal Advisor John Manning and Commissioner Libby discussed a possible incentive program.

Commissioner Libby rescinded his motion.

Commissioner Beaver rescinded her seconded.

Commissioner Libby then created a new motion based around the ideas of the motion he rescinded.

#### **MOTION: 1605:04**

Commissioner Libby made a motion for the 2016 continued education training through the Firearm Education and Training Commission be provided by certified instructors and those instructors reimbursed per the Commonwealth travel policy. No vendor will be utilized for this continued education program.

Commissioner Beaver seconded.

Motion passed by unanimous voice vote.

# Petition for Extension/Waiver

Regulation requires a doctors note with the petition, and there was no doctor note attached.

Legal Advisor John Manning added that David should know he is not capable of participating in any range qualification or in-service training.

**Jennifer Krueger** – Lawrence County Adult Probation. Requesting a medical extension for her 2016 range and 2016 in-service continuing education. Jennifer provided medical documentation backing up her claim. Jennifer originally sent the petition in on Dec. 2015 but never got through the system until now.

October 31, 2016. At such time we would ask her supervisor to re-request another extension should she not be cleared medically at that time.
