ACKNOWLEDGEMENT

Prior to participating in County Probation and Parole Officers' Firearm Education and Training Commission FORCE RESPONSE Training, I acknowledge understanding the following:

- County Probation and Parole Officers' Firearm Education and Training Commission FORCE RESPONSE Training is designed to provide participants with quality, realitybased training using force-on-force exercises against another person or persons who can shoot back.
- 2. County Probation and Parole Officers' Firearm Education and Training Commission FORCE RESPONSE Training will require that participants fire simulated rounds at one another.
- 3. The use of simulated rounds demand the same firearm handling precautions as duty ammunition and the reloading of magazines is <u>strictly prohibited</u>.
- 4. Some simulated rounds leave a detergent-based, water-soluble, color marking compound residue upon or after impact. Clothing may be stained or damaged.
- 5. Participation in County Probation and Parole Officers' Firearm Education and Training Commission FORCE RESPONSE Training requires that I wear, at all times, appropriate protective equipment as per manufacturer requirements and that nonlethal injuries, including but not necessarily limited to, bruises, welts or scrapes may occur during this training.
- 6. Only firearms that have been converted to or are primarily dedicated to safely firing simulated rounds will be used during County Probation and Parole Officers' Firearm Education and Training Commission FORCE RESPONSE Training. The use of any other firearm during this training is <u>strictly prohibited</u>.
- 7. For safety reasons, it is recommended that shooters maintain a minimum three (3) foot safe distance (standoff) between themselves and their targets when firing simulated rounds at personnel.
