MOTION 1105.03: Motion was made to grant Constructive Credit to all Certified Firearm Instructors who attend a train-the-trainer event or any other Instructor-level training outside of the Commission trainings.

NOTABLE COMMISSION MOTIONS PASSED IN JULY

MOTION 1107.02: Motion was made to approve the expenditure of up to \$5000 to contract the Tactical Practical Medical training.

MOTION 1107.03: Motion was made to rescind prior motions 0703.05 and 0703.06 which prescribe a mandatory initial in-service training course after an officer completes the Basic Training Academy. Upon completion of a Basic Firearm Training Academy (Course 1), continuing education credit will be granted for any commission in-service training an officer attends.


