1. Requirements of the award; remedies for non-compliance or for materially false statements

7. Requirement to report potentially duplicative funding

16. Effect of failure to address audit issues

21. Restrictions on "lobbying"

In general, as a matter of federal law, federal funds awarded by OJP may not be used by the recipient, or any subrecipient ("subgrantee") at any tier, either directly or indirectly, to support or oppose the enactment, repeal, modification, or adoption of any law, regulation, or policy, at any level of government. See 18 U.S.C. 1913. (There may be exceptions if an applicable federal statute specifically authorizes certain activities that otherwise would be barred by law.)

24. Restrictions and certifications regarding non-disclosure agreements and related matters

25. Compliance with 41 U.S.C. 4712 (including prohibitions on reprisal; notice to employees)

Pursuant to Executive Order 13513, "Federal Leadership on Reducing Text Messaging While Driving," 74 Fed. 29. The recipient agrees to cooperate with any assessments, national evaluation efforts, or information or data collection requests, including, but not limited to, the provision of any information required for the assessment or evaluation of any activities within this project.

*SPECIAL CONDITIONS*

36. Grantees agree to cooperate with BJA by annually assessing, through engagement with prosecutor and public defender offices, the impact of the John R. Justice Grant Program on the recruitment and retention of prosecutors and public defenders in the state or territory. This may be accomplished qualitatively, through surveys, leader interviews, a focus group or other methods. As part of this responsibility, Grantees will be required, on a schedule to be determined by BJA, to submit to BJA a copy of the impact assessment(s) by uploading the same into GMS (or in a manner otherwise prescribed by BJA).
37. Subawards using these funds shall be made to lending institutions holding qualifying loans and may not be made directly to an individual beneficiary. No JRJ funds may be applied to repay a loan described in 42 U.S.C. §3797cc-21(b)(3)(B).
38. In accepting this award, the State recipient hereby certifies:
- (1) that all prior awards made by the State under this program, have satisfied the John R. Justice (JRJ) program's statutory requirements with respect to the eligibility of each individual beneficiary of a JRJ award (as either a "prosecutor" or "public defender" as those terms are defined in 42 U.S.C. §3797cc-21(b)(1) and (2) respectively) and with respect to the loans held by such individuals (as defined in 42 U.S.C. §3797cc-21(b)(3));

40. Recipient may not obligate, expend, or drawdown funds unless and until it has uploaded to the Grants Management System (GMS) (or by a method otherwise prescribed by BJA) the following documents: 1) all John R. Justice Student Loan Repayment Program (JRJSLRP) Service Agreements, Secondary Service Agreements (including any addenda and associated documentation) properly executed by participating beneficiaries in the fiscal year supported by this award; 2) all outstanding JRJSLRP Service Agreements and Secondary Service Agreements (including any addenda and associated documentation) properly executed in prior fiscal years that have not already been uploaded into GMS by the Recipient; 3) a complete list of recipients of JRJ benefits issued by the Recipient, including a reference to the grant award number from which beneficiary funds were paid; 4) a complete list of individuals (if any) who have had JRJ benefits paid on their behalf by the Recipient, but who have left the program prior to fulfilling their service obligation, including a reference to the grant award number from which said JRJ benefits were paid. Recipient shall complete these tasks no later than one hundred and eighty (180) days from the date of this award. A Grant Adjustment Notice (GAN) is required prior to the removal of this special condition.
41. By accepting this award, the recipient agrees to abide by and comport with all requirements, applicable definitions, and conditions of the authorizing statute (34 U.S.C. 10671) and any related regulations or other guidance promulgated by the Department of Justice.
