Adelphoi Village provides various types and levels of residential treatment programs for male and female youth across Pennsylvania. Types of treatment include: General Secure Care/Male and Female; Secure Care for Sex Offenders/Male; Independent Living Group Homes/Male; Drug and Alcohol Group Home/Male; Intensive Supervision Group Homes/ Male and Female (inclusive of a specialty unit with a mental health focus/Female; and Shelter/Male and Female. Treatment is individualized, designed to address a number of criminogenic risk factors, inclusive of anger and aggression issues, poor problem solving, mild to moderate mental health issues, strained family dynamics, and trauma. Adelphoi Village's philosophy is that the cycle of degeneration can be altered in favor of positive growth and success through applying the beliefs and principles of brotherly concern coupled with proven modalities.

Youth are placed by the courts within one of Adelphoi Village's Intensive Supervision Group Homes at varied stages of court involvement. This may be the initial out of home placement for a youth or placement here may be upon the court transitioning a youth from a more restrictive level of care, inclusive of stepping down a youth from a secure placement. The average length of stay varies across Adelphoi Village's different program types with the average length of stay for a youth within one of Adelphoi Village's Intensive Supervision Group Homes falling within the 5-6 month range.

With few exceptions, youth placed within these group homes participate in Aggression Replacement Training® (ART®), designed to alter the behavior of chronically aggressive adolescents. The program incorporates: skill-streaming, anger-control training, and moral reasoning.

The intended use of the SPEP is to optimize the effectiveness of reducing recidivism among juvenile offenders. Recommendations for performance improvement are included in the service feedback report, and these recommendations are the focus of the performance improvement plan, a shared responsibility of the service provider and the local juvenile court. The recommendations for this service included in the feedback report are:

The Adelphoi Village Intensive Supervision Male Programs' service of Aggression Replacement Training (ART) scored an 89% Program Optimization Percentage. This intervention was categorized as a Group 5 service; Cognitive-Behavioral Therapy with no qualifying supplemental service. The quality of the service was found to be delivered at a High level. The risk levels of youth participating in this program are: 0% as Low Risk; 100% as Moderate Risk or above; and 30% as High Risk. The amount of service provided to the clients was at 60% of the recommended targeted weeks of duration and 70% of the recommended target contact hours for this service type.

The Adelphoi Village Intensive Supervision Male Programs could improve their capacity for recidivism reduction through:

1. Identifying an operational strategy to facilitate Anger Control Groups in a closed group format as recommended by Educational Training Alternatives, ETA.
2. Acquiring more Train-the-Trainers within the Agency in order to ensure high fidelity of service delivery.
3. Improving communication with Allegheny County Juvenile Court and other courts that use this service on the research amount of service that should be provided for this service type.
4. Utilizing assessments (i.e. Skill Streaming Checklist, AQ, and How I Think) to determine which components of ART can most benefit youth that receive the service as recommended by Educational Training Alternatives, ETA.
5. More consistent utilization of pre and post tests to measure ART outcomes for the agency as recommended by Educational Training Alternatives, ETA.

Aggression Replacement Training® (ART®) consists of a 10-week, 30-hour intervention administered to groups of 8 to 12 juvenile offenders thrice weekly. During these 10 weeks, participating youth typically attend three 1-hour sessions per week, one session each of Skillstreaming, Anger Control Training, and training in Moral Reasoning. The program relies on repetitive learning techniques to teach participants to control impulsiveness and anger, resulting in using more appropriate behaviors. In addition, guided group discussion is used to correct antisocial thinking.

The recommendations for this service included in the feedback report are:

Aggression Replacement Training® (ART®) scored an 89 for the Basic Score and an 89% Program Optimization Percentage. It is classified as a Group 5 service; Cognitive-Behavioral Therapy service type. These scores show no difference in percentage points from the baseline findings of the initial SPEP™ assessment. Due to the high quality of service delivery, found in both SPEP™ assessments, there are no identified recommendations for performance improvement.

Description of Service:

Headquartered in Latrobe, PA, Adelphoi has programs in over 30 counties, including residential group homes, foster and adoptive care, education services, and in-home treatment options. Adelphoi serves 1200 children, youth, and families each day. Each residential program is designed to meet the individualized needs of youth in placement. As treatment needs change, a unique continuum of care model allows youth to move from one program to another in a way that will ensure success. Education is provided on-site or through Adelphoi's Ketterer Charter School. Adelphoi encourages participation by the family in the youth's treatment and offers family visitation assistance.

Adelphoi provides various types and levels of residential treatment programs for male and female youth across Pennsylvania. Types of treatment include: shelter, diagnostic, specialized independent living, intensive supervision, intensive supervision with a mental health focus, substance use, sex offender treatment, enhanced supervision, and secure care. Treatment is individualized and designed to address a number of criminogenic risk factors, including anger and aggression issues, poor problem solving, mild to moderate mental health issues, strained family dynamics, and trauma. Adelphoi's philosophy is the cycle of degeneration can be altered in favor of positive growth and success through application of the beliefs and principles of brotherly concern coupled with proven treatment modalities.

Intensive Supervision Group Homes provide community-style living to chronically delinquent or dependent male and female youth. The program offers community-based mental health services and medication management, as well as on-site psychiatric and psychological services. Youth are placed by the courts within one of Adelphoi's Intensive Supervision Male Group Homes at varied stages of court involvement. This may be the initial out-of-home placement for a youth or may be upon the court transitioning a youth already in placement who is within a more restrictive/secure level of care, to a less restrictive level of care. The average length of stay varies across Adelphoi's different program types.

Aggression Replacement Training® (ART®) is an evidence-based curriculum proven to help juveniles reduce aggressive behavior and develop pro-social and moral reasoning skills. ART® is a multimodal psycho-educational intervention designed to alter the behavior of chronically aggressive adolescents and young children. The program incorporates three specific interventions: Skillstreaming, Anger Control Training, and Moral Reasoning Training.

- Skillstreaming uses modeling, role-playing, performance feedback, and transfer training to teach pro-social skills.

- Anger Control Training requires participating youth to bring one or more descriptions of recent anger-arousing experiences (hassles) to each session. Over the duration of the program, youth are trained in how to respond to their hassles.

- Moral Reasoning Training is designed to enhance youths' sense of fairness and justice regarding the needs and rights of others. It is also designed to train youth to imagine the perspectives of others when they confront various moral problem situations.

ART® consists of a 10-week, 30-hour intervention administered to groups of 8 to 12 youth three times weekly. During these 10 weeks, participating youth typically attend three 1-hour sessions per week, one session each of Skillstreaming, Anger Control Training, and Moral Reasoning Training. The program relies on repetitive learning techniques to teach participants to control impulsiveness and anger, resulting in using more appropriate behaviors. In addition, guided group discussion is used to correct antisocial thinking. Differences exist regarding the targeted duration (i.e., weeks) and contact hours for the delivery of ART® in a residential program versus delivery of ART® in a community-based program.

The SPEP™ and Performance Improvement

The intended use of the SPEP™ is to optimize the effectiveness of reducing recidivism among juvenile offenders. Recommendations for performance improvement are included in the service Feedback Report, and these recommendations are the focus of the Performance Improvement Plan, a shared responsibility of the service provider and the juvenile probation department.

ART® received a 94 for the Basic Score and a 94% Program Optimization Percentage. The Basic Scores represent an increase of 5 percentage point(s) from the previous SPEP™ Reassessment and an increase of 5 percentage point(s) from the initial SPEP™ Assessment. The POP Scores represent an increase of 5 percentage point(s) from the previous SPEP™ Reassessment and an increase of 5 percentage point(s) from the initial SPEP™ Assessment.

The service was classified as a Group 5 service; Cognitive-behavioral Therapy Service Type. There is no qualifying supplemental service found in the research. The Quality of Service was found to be at a High Level. For Amount of Service, 89% of the youth received the recommended targeted weeks of duration and 96% of the youth received the recommended targeted contact hours for this service type. The Risk Levels of Youth admitted to the service were: 10% low risk, 48% moderate risk, 40% high risk, and 2% very high risk.
