Wesley Family Services accepts referrals to the following services specifically from the Juvenile Justice System and Child Welfare agencies to provide stability and support to individuals and families: Aggression Replacement Training® (ART®) – social skill building for teenagers with anger and aggression management issues in the community and in the schools; Family Based Mental Health Services (FBMHS) – family therapy, crisis intervention, prevention services, and service coordination for families with at least one child who is at risk for a higher level of care in the home; In-Home Family Preservation and Stabilization – stability through family therapy services for children & families in the Juvenile Justice system with risk factors that may result in a child's removal from the home; services are provided in the home, at school, in detention/shelter, or in a community setting; Court Competency Curriculum – 10-session curriculum offered to youth who have been identified as incompetent to stand trial; the curriculum is delivered by trained therapists to assist those youth in better understanding the Juvenile Justice System & processes in the hopes of increasing the youth's capacity to participate in the system; Foster Care, Adoption, and Post Permanency Services – adoption services for children and teens with need for permanency in home; Functional Family Therapy-Child Welfare (FFT-CW) – strengthens families by providing a supportive environment, assistance, and recommendations through five distinct phases of therapy for those that need to improve their relationships; and ParentWISE Education Classes – education classes for parents, caregivers and people who work with children in one of our facilities, virtually, or in the community

The focus of this report is Aggression Replacement Training® (ART®). Wesley Family Services has provided ART® to youth referred by Allegheny County Juvenile Probation (JPO) for several years. Prior to the COVID pandemic, services were offered at the Allegheny County Courthouse on Saturday mornings. However, this design has not been feasible post-pandemic. Wesley Family Services now has their own site at which services are delivered; Wesley Family Services transports youth to the group location and oversees ART® facilitation. Allegheny County JPO refer juveniles on their caseloads to ART® if youth can benefit from this competency development program, based on the charge type or Youth Level of Service risk/needs assessment.

Aggression Replacement Training® (ART®) is an evidence-based curriculum proven to help juveniles reduce aggressive behavior and develop pro-social and moral reasoning skills. ART® is a multimodal psycho-educational intervention designed to alter the behavior of chronically aggressive adolescents and young children. The program incorporates three specific interventions: Skillstreaming, Anger Control Training, and Moral Reasoning Training.

2. <u>Quality of Service</u> : Research has shown that programs that deliver service with high quality are more likely to have a positive impact on recidivism reduction. Monitoring of quality is defined by existence of written protocol, staff training, staff supervision, and how drift from service delivery is addressed.

3. <u>Amount of Service</u> : Score was derived by calculating the total number of weeks and hours received by each youth in the service. The amount of service is measured by the target amounts of service for the SPEP TM service categorization. Each SPEP TM service type has varying amounts of duration and dosage. Youth should receive the targeted amounts to have the greatest impact on recidivism reduction. Targeted duration and dosage for this service is <u>8</u> weeks, <u>24</u> hours.

4. <u>Youth Risk Level</u> : The risk level score is compiled by calculating the total % of youth that score above low risk, and the total % of youth who score above moderate risk to reoffend based on the results of the YLS. The Risk Levels of Youth admitted to the service were: 7 low risk, 23 moderate risk, 6 , high risk, and 0 very high risk.

The SPEPTM and <u>Performance Improvement</u>

The intended use of the SPEP[™] is to optimize the effectiveness of reducing recidivism among juvenile offenders. The service could improve its capacity for recidivism reduction by addressing the following recommendations:

Service delivery was impacted by the COVID-pandemic. Wesley has assumed responsibility for securing the location of group sites and provides transportation to youth participants. This is in direct contrast to pre-pandemic practices in which services were delivered weekly at the County Courthouse. Fidelity monitoring and data collection were also impacted by the pandemic, with limited use of the recommended tools. This deficiency has been addressed with the most recent cohort.

- 1. Regarding Quality of Service Delivery:
 - a. Organizational Response to Drift:
 - i. Consistently maintain use of developer-recommended tools and checklists to monitor the quality & fidelity of service delivery.

2. Regarding Amount of Service:

a. Monitor trends related to early discharge and collaborate with Allegheny County Juvenile probation to address concerns if they arise.
