Sessions include as many family members as possible and are designed to address criminogenic risk factors such as unsafe and/or unstable family settings, poor parenting, adverse family interactions, disengagement from school/community/work, behavioral health, substance abuse, and lack of pro-social relationships. In-Home Services include: assessing family functioning to aid in service plan development and providing family counseling about relationships, domestic violence, parent/child conflict, crisis management, communication, peer relationships, anger management, problem-solving, and budgeting. Wesley Family Services has used the Performance Improvement Plan (PIP) of the SPEPTM process to enhance their delivery of IHS across multiple SPEPTM cycles.
