Description of Service:

Abraxas I, a division of Abraxas Youth and Family Services, is located in rural Marienville, PA and offers a variety of programs within the campus including: The Social Training and Education Program (STEP), The Intensive Open Residential Program (IORP), The Abraxas Residential Mental Health Services (ARMHS) Program and The Abraxas I Intensive Drug & Alcohol Treatment Programs. Abraxas I is a Sanctuary® Model affiliated program which provides guidance in support of a trauma informed, trauma sensitive culture by employing the Seven Commitments of the Sanctuary® Model, along with the Sanctuary® Toolkit.

The focus of this report is on the New Directions: Criminal & Addictive Thinking service delivered in the Abraxas I Intensive Drug and Alcohol Treatment Programs. These programs provide intensive substance abuse programming for 60 adolescent males and 32 female adolescents in separate treatment settings. The programs provide a safe, nurturing and structured environment for delinquent and/or dependent youth to make positive changes in their behaviors, attitudes and beliefs. The goal of treatment is to eliminate drug abuse/dependency & delinquency and develop competencies that will enable youth to function as responsible members of the community. Youth participate in a variety of therapeutically structured activities. Treatment planning integrates the concepts of Balanced and Restorative Justice by focusing on offense-specific counseling, victim awareness, accountability and competency development.

New Directions is a comprehensive, cognitive-behavioral therapy (CBT) treatment program that trains chemically dependent youth to challenge their thinking in order to change their delinquent and addictive behavioral problems. The curriculum includes real stories about recovering from a life of addiction and crime; a cognitive-behavioral approach helps youth see how their attitudes and assumptions fuel destructive behaviors. The modular structure allows for easy customization to meet individual needs. New Directions features built-in tools for measuring outcomes and provides a framework for standardized treatment. Criminal & Addictive Thinking is one of eight modules of Hazelden's New Directions curriculum. Criminal & Addictive Thinking helps youth explore the distorted thinking patterns at the root of addiction and criminal behavior. Criminal & Addictive Thinking includes 26, one-hour sessions intended to be delivered weekly in an open group format; group size is typically 15 youth. The intended use of the SPEPTM is to optimize the effectiveness of reducing recidivism among juvenile offenders. Recommendations for performance improvement are included in the service Feedback Report, and these recommendations are the focus of the Performance Improvement Plan, a shared responsibility of the service provider and the juvenile probation department.
