Description of Service:

The Academy Community Based Program offers daily, face-to-face contact, supervision, and 24/7 emergency intervention availability. The program allows students to remain in their home and community while addressing their educational, social, behavior, and employment needs. The Academy utilizes the Balanced and Restorative Justice (BARJ) principles of accountability, competency development, and community protection. The purpose of The Academy Community Based Program is: (1) To provide opportunities and development to avoid further involvement with the juvenile justice system; (2) To provide structure and accountability for the students processed through the juvenile justice system; (3) To monitor school attendance and academic progress; (4) To reduce overall recidivism; (5) To help students avoid detention or residential placement; (6) To help students avoid detention or residential placement for non-payment of restitution owed to the courts. The Academy's Community Specialists focus on facilitating positive community, school, and family involvement to increase behavioral accountability and life skills development. This, in conjunction with supervision, counseling, and intervention is geared to help youth reach the ultimate goal of eliminating further contact with the criminal justice system.

Community Based Services (CBS): All youth referred to The Academy receive this service as a community-based treatment for placement prevention or aftercare from residential placement. The service allows students to remain in their home and community while addressing their educational, social, behavior, and employment needs. All youth are assigned a Community Specialist, who works with the youth for the duration of the service. The Community Specialist will use the YLS and probation recommendations to complete an intake within 72 hours of court referral to determine youth treatment needs as it relates to home, community and school needs to include truancy concerns. The Community Specialist will develop a treatment plan for the youth and provide face-to-face contact (these can occur as often as daily), supervision, and 24/7 emergency intervention availability as youth achieve their goals through various activities, interventions and treatment methods. This includes services such as, court appearances, case supervision, and transportation. The Community Specialist can also provide community linkage to employment education and career readiness services and can also assist youth with resume writing and finding employment. They also perform curfew checks, contact the youth's probation officer 3 times per week, and provide family meetings as well as updates to the family weekly, or as necessary, to discuss progress, changes, or problems with the youth.

The SPEP™ and Performance Improvement

The intended use of the SPEPTM is to optimize the effectiveness of reducing recidivism among juvenile offenders. Recommendations for performance improvement are included in the service Feedback Report, and these recommendations are the focus of the Performance Improvement Plan, a shared responsibility of the service provider and the juvenile probation department.

Community Based Services received a 37 for the Basic Score and a 49% Program Optimization Percentage. It was classified as a Group 1 service; Individual Counseling Service Type. There is no qualifying supplemental service found in the research. The Quality of Service Delivery was found to be at a High Level. For Amount of Service, 6% of the youth received the recommended targeted weeks of duration and 33% of the youth received the recommended targeted weeks of duration and 33% of the youth received the recommended targeted weeks of Youth admitted to the service were: 41% low risk, 53% moderate risk, 6% high risk, and 0% very high risk. The service could improve its capacity for recidivism reduction by addressing the following recommendations:

- 1. Regarding Quality of Service Delivery:
 - a. Staff Supervision:
 - i. Ensure all supervisors provide written feedback to delivery staff via the Weekly Supervision Form, and incorporate it into policy and procedures.
- 2. Regarding Amount of Service:
 - a. Maintain collaboration with Chester County Juvenile Probation to ensure that youth receive the research supported amount of service recommended for this type of service.
- 3. Regarding Risk Level of Youth Served:
 - a. All youth referred to Community Based Services should continue to receive the service despite their YLS/CMI risk level in accordance with Chester County Juvenile Probation.
