



## VIP & BOOST FUNDING OPPORTUNITIES FOR NONPROFIT ORGANIZATIONS

**Solicitations below are open to nonprofit 501(c)(3) organizations in Pennsylvania unless otherwise specified. Please select the solicitation that is the best fit for your proposed project:**

### SOLICITATION 1: FY 2024 VIP Grants

- Approximately \$40-45 million in funding is available to support a wide range of intervention and response strategies designed to reduce community violence.
- Two VIP application ‘tracks’:
  - **VIP Track 1: VIP Expansion, Enhancement, or Continuation Grants for Established Programs** to support existing, established programs and entities already in place for at least two years with demonstrated impact and organizational capacity managing grant funds. Maximum award is up to \$950,000 or 50% of operating expenditures for 36-month project starting March 1, 2025.
  - **VIP Track 2: VIP Start-up Grants** to provide financial, technical, and training support to grassroots organizations to help them launch programs and strengthen capacity. Will be required to participate in technical assistance and coaching supports. Maximum award is up to \$100,000 or 50% of operating expenditures for 18-month project starting March 1, 2025.

### SOLICITATION 2: FY 2024 Collaborative Community Violence Intervention (CCVI) Strategies Grants

- Approximately \$5-6 million in funding is available to support collaborative responses to community violence.
- Two CCVI application ‘tracks’:
  - **CCVI Track 1: Planning Grants** to provide funding for local jurisdictions (counties, municipalities) to support the development of violence reduction plans. Maximum award is up to \$75,000 or 50% of operating expenditures for 18-month project starting March 1, 2025.
  - **CCVI Track 2: Implementation Grants** to advance collaborative, community-driven strategies to reduce violence in counties and municipalities with the highest rates of gun incidents and increasing homicides from 2022 to 2023 that have a recently completed violence reduction plan developed with a [Violence Reduction Council](#) or similar body. Maximum award is up to \$2 million (match required) for 36-month project starting March 1, 2025.

### SOLICITATION 3: FY 2024 Building Opportunities for Out-of-School Time (BOOST) Grants

- \$11.5 million in funding is available to support statewide youth-serving nonprofit organizations and community-based nonprofit organizations providing out-of-school time (OST) programming for at-risk school-age youth.
- Two BOOST application ‘tracks’:
  - **BOOST Track 1: Local BOOST Projects** supporting local OST structured programming opportunities for at-risk school-age youth. Maximum award is up to \$250,000 or 50% of operating expenditures for 24-month project starting February 1, 2025.
  - **BOOST Track 2: Statewide BOOST Projects** to support statewide youth-serving nonprofit organizations with 501(c)(4) status affiliated with a national organization applying for funds on behalf of three or more subrecipients providing OST programming for at-risk school-age youth. Maximum award is up to \$1.5 million for 24-month project starting February 1, 2025.
