The following are all the currently open School Safety and Security Funding Announcements for Nonpublic Schools:

2024-25 Targeted School Safety Grants for Nonpublic Schools

Initial Request Form due date: 9/26/24

- **Nonpublics will submit an Initial Request Form directly to PCCD via SurveyMonkey – see [Targeted School Safety Grants for Nonpublic Schools](#) webpage for more information about the process and to apply.**
- Competitive solicitation of approximately \$19.7 million.
- Nonpublic schools meeting definition of [Section 923.3-A of the PA Public School Code](#) are eligible to apply. Maximum award is \$75,000 per applicant for an up-to 18-month project.
- Funding can be spent on any activities under [Section 1306-B\(J\)](#).
- Priority consideration will be given to schools seeking to meet [Level 1 Baseline Criteria](#) or fulfill security assessments.

****NOTICE**** New for FY24-25 – Per recent changes in the law by Act 55 of 2024, nonpublic schools recommended for an award will no longer need to formally apply through their respective Intermediate Unit to receive funding. Applicants recommended for award in November will work directly with PCCD staff to submit their application within PCCD’s Egrants system. Helpful Tips When Using SurveyMonkey

- It is **strongly recommended** that you review the **written funding announcement and PDF version of the SurveyMonkey initial request form** and prepare all of your application’s text in advance (in Microsoft Word or some similar software) prior to filling out the SurveyMonkey form. While easy to navigate, SurveyMonkey can ‘time out’ at times due to long pauses, and you may lose some work in the process. PCCD recommends preparing all documents in advance and then filling the SurveyMonkey form out in one sitting.
- The SurveyMonkey initial request form is formatted to only accept one survey per IP, or per computer/device. If seeking to submit multiple applications, applicants can try to utilize different web browsers (e.g., Google Chrome, Mozilla Fox, Opera, Safari, Microsoft Edge, etc.) or deleting the browsers’ cookies. If those options do not work, you may need to utilize another computer/device to create and submit another application.
