## The Role of Lived Expertise in Advancing Stepping Up

In this session, Council of State Governments (CSG) Justice Center staff will provide an overview of Stepping Up and the PA TA Center and will discuss a new key area of focus: incorporating the voices of people with lived expertise into this work. People with lived expertise bring a unique perspective through their firsthand knowledge, which can help counties implement more effective responses to people with behavioral health needs in the justice system and address any disparities identified. Despite it's understood importance, counties struggle to meaningfully engage people with lived expertise in this work. This session will cover the continuum of different types of engagement, from simple outreach through surveys and public forums to shared leadership roles, as well as how counties can set the stage for meaningful engagement. It will then provide a more in-depth look at one level of engagement from the CSG Justice Center's Stepping Up team, a lived experience advisory committee/panel, and steps counties can take to establish their own advisory panels.

## Confidentiality: The Intersection Between the Addiction Treatment and Criminal Justice Systems

For decades, Pennsylvania addiction treatment providers operated under confidentiality regulations stricter than federal rules. These rules often created friction between the addiction treatment and criminal justice systems. In late 2022, a new confidentiality law passed in Pennsylvania, aligning the commonwealth with federal law. Still, a lack of awareness and misunderstanding continue to drive frustration between the two systems. A panel of experts from both systems will discuss the issue and specific challenges and seek solutions.

### CJAB and EBP: How Each Can Support the Efforts and Impact of the Other

Evidence-based practices (EBP) is often seen as a probation initiative. CJAB stakeholders may struggle with their role in the implementation process. The Pennsylvania Partnership for Criminal Justice Improvement has developed a messaging campaign that highlights the importance of stakeholder engagement in EBP implementation to create safer and healthier communities. At the workshop, speakers will examine the critical impact of these agency roles and demonstrate how one county, through the effective utilization of its CJAB, has improved outcomes.

## The NEW Definition of Pardons: No-Cost Workforce Development and Community Investment

Criminal convictions are permanent, unless and until they are erased (expunged) by a judge; and a judge cannot expunge a conviction unless it has been first pardoned by the Governor. In most states, the Governor pardons a handful of people every Christmas; in Pennsylvania, Gov. Wolf pardoned 2500 over his two terms. The reason: pardons are now understood as "workforce development and community investment policies". The program will explain pardons and how communities can come together to create "Pardon Projects".
