# Breaking the Cycle of Community Violence through Holistic and Effective Evidence-Based Practices

Keynote 9:15 a.m. – 10:30 a.m. Presidents Hall Despite increased public attention to gun violence since 2020, Black and disadvantaged neighborhoods have historically experienced disproportionate levels of community violence, especially among young Black men. Implementing intelligence-driven policing, community intervention, public-private partnerships, and sensible legislation can address the allure of street life and urban gun culture contributing to felony violence in these neighborhoods. Evidence-based justice system and community interventions offer promising perspectives to reduce gun violence without widening the racial gap in arrests and imprisonment.

# Mind Matters: Building a Crisis System That is Inclusive and Responsive to Brain Injury

It is estimated that over half of individuals encountering the criminal justice system have experienced a brain injury, making this a highly prevalent issue of concern among persons involved in the criminal justice system and those working within the system. Brain injury advocates have lobbied extensively for legislative and funding support to address this issue. Recently, progress was made on the legislative front with the Traumatic Brain Injury and Post-Traumatic Stress Disorder Law Enforcement Training Act (H.R. 2992), which was signed into law in August 2022 and promotes the development of training tools and resources for first responders focused on brain injuries and post-traumatic stress disorder.

Policy experts at the Council of State Governments (CSG) Justice Center reviewed existing literature, best practices, and policies on brain injury and conducted a series of interviews and focus groups with criminal justice professionals, brain injury service providers, advocacy organizations, and subject matter experts. Insights from the literature scan, interviews, and focus groups were integrated into a comprehensive report, which outlines key findings and recommendations to advance the field in addressing the issue of brain injury within the criminal justice system.

This session will outline key findings derived from the CSG Justice Center's report and discuss recommendations for criminal justice professionals to inform policy and practice at the intersection of brain injury and the criminal justice system. During the session, participants will: 1) learn what brain injury is, how it presents itself in the criminal justice system, and the key issues when identifying and addressing brain injury in criminal justice settings; 2) gain an understanding of key recommendations for how to identify and appropriately address brain injury in criminal justice settings; and 3) receive key resources to support the implementation of best practices to improve responses to persons living with brain injury encountering the criminal justice system.

The intent was to use a targeted participant selection process, the utilization of new resources, deployment of highly trained and dedicated staff and a holistic approach to improve the outcomes for the population assigned to the program.

Trauma exposure is an unavoidable occupational hazard in criminal justice work, creating vicarious trauma for staff at all levels, at every stage of the justice system. Unfortunately, vicarious trauma is highly contagious and can infect the entire culture with cynicism, communication breakdowns, unresolved conflicts, increased potential for aggression, and other serious risks. This workshop will equip agency leaders with practical, proven and readily-implementable strategies to mitigate negative impacts of trauma exposure, minimize risk of trauma contagion, ensure a safe, healthy organizational culture, and promote staff well-being.

## Preliminary Recidivism Rates: What Can the Data Tell Us About EBP and Risk Assessments?

This session will highlight the initial findings of a recidivism study funded through a Bureau of Justice SMART Probation grant. The study focuses on three demonstration sites: Berks, Dauphin, and York County adult probation departments. Recidivism rates among low, moderate, high, and very high-risk individuals under supervision were evaluated to validate ORAS outcomes and as a foundational step toward a larger goal of establishing causality between implementation of EBP and recidivism reduction.

## The Formation of the Philadelphia Police Departments Behavioral Health Unit and **Crisis Intervention Response Teams**

In November 2022 the Philadelphia Police Department (PPD) launched a new Behavioral Health Unit (BHU) to improve police response for individuals actively suffering from various behavioral health and emotional crises. The BHU seeks to provide alternative solutions to individuals in crisis by utilizing co-responder teams, as well as diverting certain low-level arrestees from the court system into treatment programs. BHU response focuses on de-escalation and connecting individuals to supportive services and treatment programs instead of arresting them, allowing Philadelphia citizens to access the help they need to improve their quality of life and prevent them from future encounters with the police and court system. This presentation will focus on the formation of the BHU, the expansion of the Police Assisted Diversion program, and heavily focus on the role of the Crisis Intervention Response Teams in the community now that the program has one year of success and data.

# What 50 Years Has Taught Me: A Story of Addiction, Death, Redemption and Hope

Keynote 3:15 p.m. – 4:30 p.m. Presidents Hall As a person in long-term recovery who lost both of his brothers – his only siblings – to drug overdose deaths, Jason Snyder will tell his family's story of addiction, death, redemption and hope through detailed vignettes. Following a timeline that connects those milestone events in his life – interactions with the criminal justice system, addiction treatment system, healthcare system and local and state governments – to the attitudes toward and services available to treat and support those with the disease at those moments in his history, Jason will describe scenes that highlight missed opportunities to better help his brothers, his parents and himself while celebrating the progress we've made in capitalizing on those same opportunities and within those same systems today.

Calling on his professional expertise and experiences, Jason will add color and perspective to a history lesson on addiction ignorance, treatment, stigma and progress and make recommendations for where we need to go in the future.
