Data and Metrics	Compiles organizational and programmatic data and reports to drive the CJAB's vision and strategic objectives.
Reentry Committee	Ensure that individuals returning to their home communities have access to housing, transportation, treatment, and other supportive services necessary for successful reintegration, thereby reducing the likelihood of recidivation.
