The challenge: Overcrowding and increased transfers were negatively impacting offenders and Lycoming County




**Our solution**: Community-based reentry services to reduce risk of recidivating



**The results**: Reduced jail crowding, lowered LSI-R scores, fewer rearrests, increased employment rates

#### Our timeline

2012

Prison population was at capacity – Lycoming County needed to make a plan to accommodate offenders

2014

After researching several options, including building a \$45 million prison, Lycoming County decided to implement reentry services

2018

Community-based reentry services are achieving many of the desired results


2021

### Prison population was growing


**Average Daily Population**

#### **Overcrowding Transfers**




#### County lacked reentry resources \*

- Housing

#### Seek solutions to reentry issues\*

- Lack of risk/needs assessment tools
- Drug/alcohol treatment options inundated
- Lack of mentors, peer supports, other natural supports
- Lack of coordination between services
- Individual behavior, readiness to change
- Reentry planning for individual risk/needs
- Need for step-down approach to services

#### Initial options explored

**Option 1:** Add jail capacity

Cost \$45 million

**Option 2:** Alternatives to detention

- Enhanced supervision
- Pretrial diversion
- Reentry services

#### Add alternatives to incarceration


- Day Reporting

# Solution: A continuum of alternatives to incarceration

- GPS/ Electronic monitoring
- Increasing office visits to probation officer
- Mental health evaluation
- Use of Drug, Mental Health, and DUI Courts
- Use of bail program
- Use of pre-release center
- Adding Day Reporting Program



#### **Spotlight: Lycoming Reentry Service Center**

- Day Reporting program to:
  - Directly addresses the needs of the offender population
  - Manage moderate- and high-risk offenders at risk to recidivate
  - Incorporate evidence-based practices

#### **Key: Hold participants accountable**

- Frequent reporting

   Graduated reward and sanction

- Community service assignments
- Location monitoring



#### **Key: Behavior change programming**

- Risk/need assessment
- Individual treatment plan and programming with appropriate dosage
- Cognitive behavioral treatment
- Substance abuse treatment
- Life skills programming
- Anger management classes
- Aftercare



#### **Key: Focus on self-sufficiency**

- Job skills training and placement
- Community connections
- Release planning
- Housing plans
- Educational and vocational services
- Mental health assessments and referrals
- Parenting and family services



#### **Key: Establishing program metrics**

#### Key: Establish community partnerships

- Lycoming College (student projects, presentations on reentry by GEO Reentry and county APO staff)
- Relationships with County Drug and Alcohol Providers (West Branch Drug and Alcohol, Crossroads Counseling)
- Kiwanis Club presentations
- Community Connection events on community resources
- Relationship with County Landfill Creating Work Program for participants in reentry



## Key: Focus on job skills/partnerships

- Participants are employed at the County Landfill
  - Opportunities to develop job skills
  - Opportunities to gain experience
  - Opportunity to strengthen relationship with community



- Employment Readiness classes help prepare participants
  - Practice resume building & interviewing skills
- Employment assessments measure skills and competencies


### Who is eligible for Reentry Center?










## Employment rates for graduates






#### Reentry Center: 2021 drug screens






## Reentry Center completions

7 in 10 completed the program in 2021


From 2018-2020, 92% of graduates avoided jail for new charges





## Effect on prison crowding


Average Daily Population

## **Reentry Coordinator**

Understands the commitment of the county and GEO Reentry in addressing the needs of returning citizens with initiatives to reduce recidivism and increase public safety. Provides support through addressing criminogenic and basic need, developing a plan with the returning citizen, and supporting a successful transition into the community.

#### **Transition Planning**

- Assess criminogenic risk/needs ID transition goals
- Highlight areas of strength and growth
- Create a TAP (Transition Action Plan)
- Make referrals and appointments, and track for accountability
- Provide resources

#### **Cognitive Behavioral Therapy**

- One-on-one sessions with participants
- Carey Guides & Motivational Interviewing

## **Reentry Coalition & Outreach**

"The mission of the Lycoming County Reentry Coalition is to facilitate and support the successful return of incarcerated individuals to the community. In partnership with government entities, faith and community-based organizations, and other stakeholders, the Reentry Coalition will utilize a holistic approach that includes an emphasis on education, families, health services, treatment, employment, mentorship and housing. In pursuing this mission, we shall improve lives, reduce recidivism, and enhance public safety."

- The Reentry Coordinator is responsible for organizing and running the Quarterly Meeting and being the main point of contact for the coalition.
  - Keeps track of subcommittees and attends their meetings when available. (Employment, Menta Health/ Substance Abuse)
  - Tracks all data relating to position and reports data to CJAB, GEO, LCP, and The County Prison Board.
  - Attends CJAB, CJAB subcommittee, Prison Board, weekly prison meetings, Forensics Meeting, and other community/county meetings/events as needed.
- Current goal is to grow Coalition and develop more subcommittees, bring in more community members, and attend more community events. (ex. First Fridays on Pine Street)
